☐ Read and obey all posted information and warnings.

☐ Comply promptly with all verbal directions of Seminar committee members and/or PKC officers unless I believe that by doing so I will endanger myself, other people or pets, in which case I will immediately express my opinion to the person involved.

☐ Refrain from acting in any manner that may cause or contribute to my injury or the injury of other

☐ Be constantly aware of, anticipate, and be able to avoid nearby pets, people, obstacles and natural or man-made hazards.
